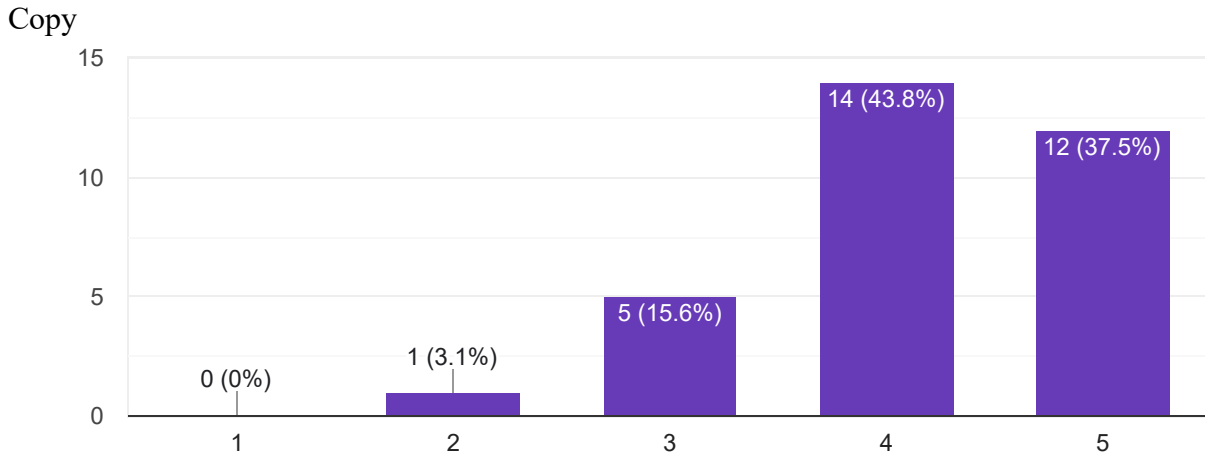
For how many years have you been teaching at SD College Barnala? 32 responses



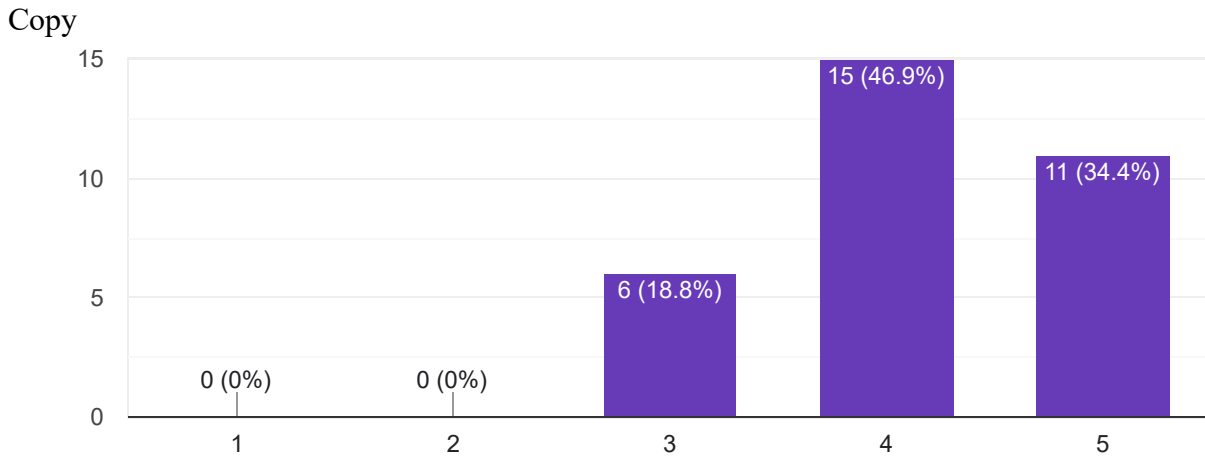
Do you find the duration of the semester for completion of syllabus sufficient? 32 responses

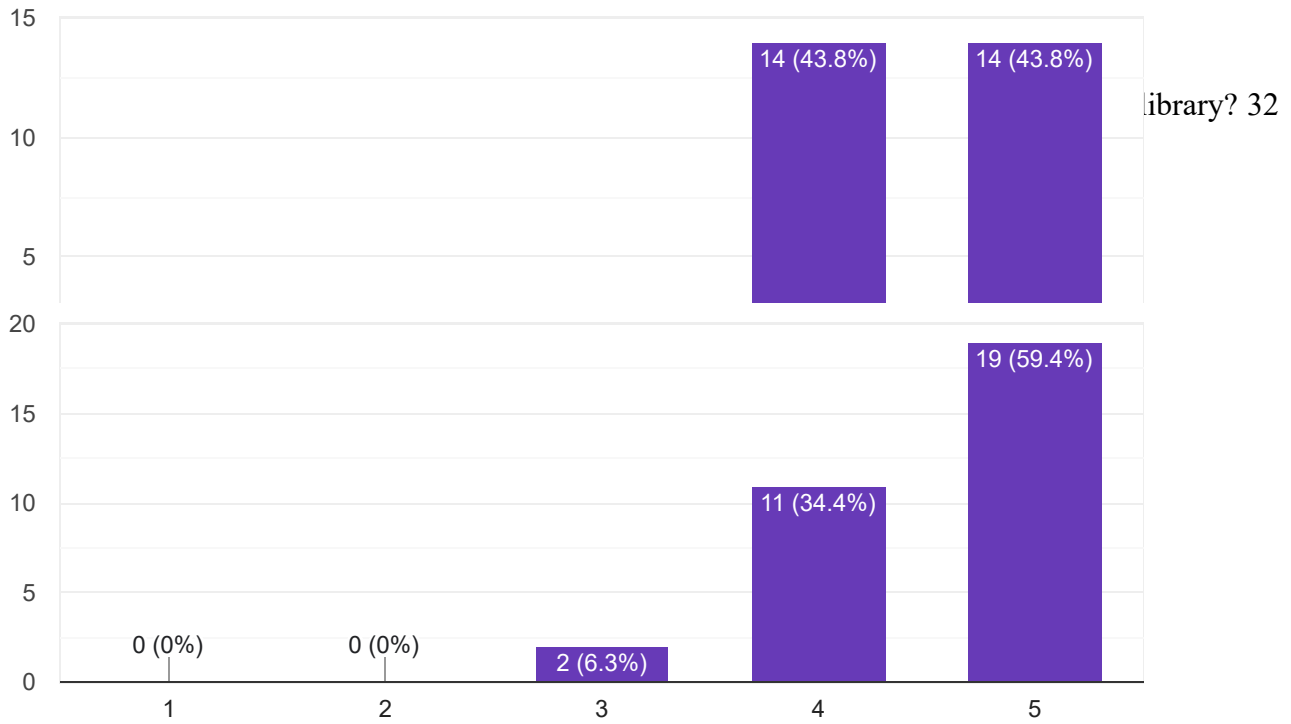

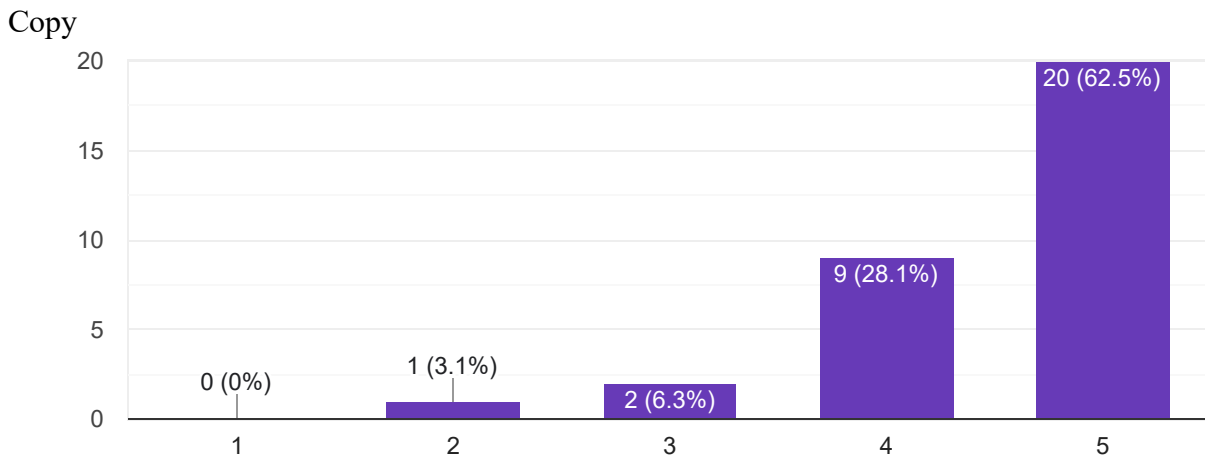

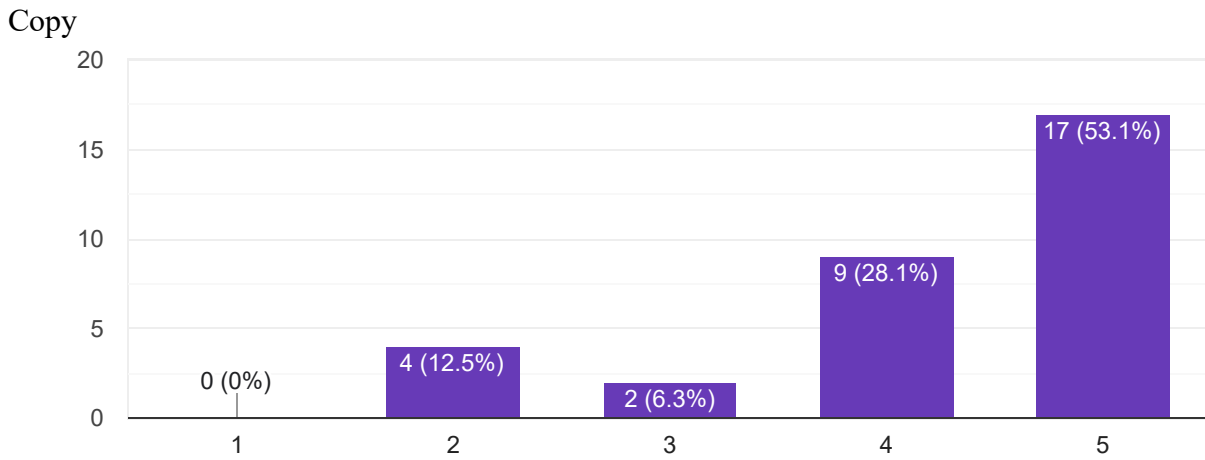


How would you rate the efficiency and behavior of the employees of the administrative department in their dealing with teachers and students? 32 responses

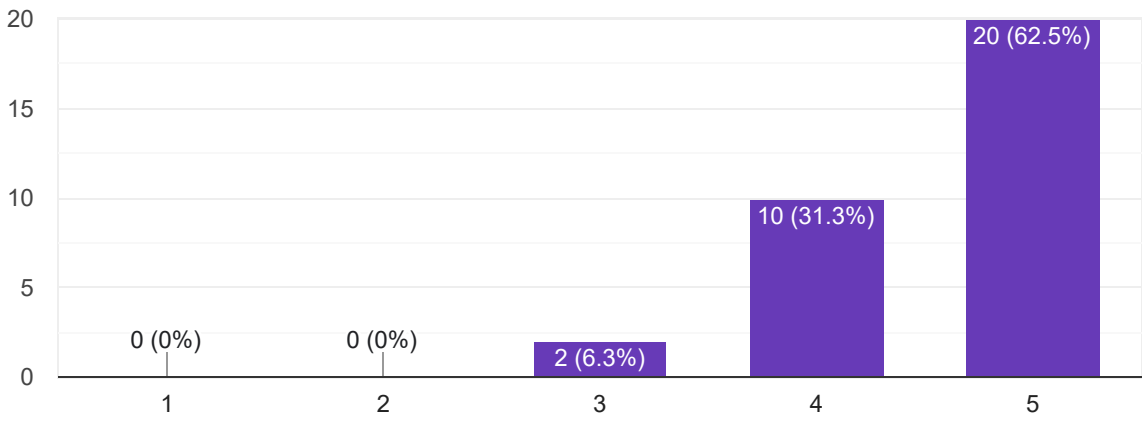
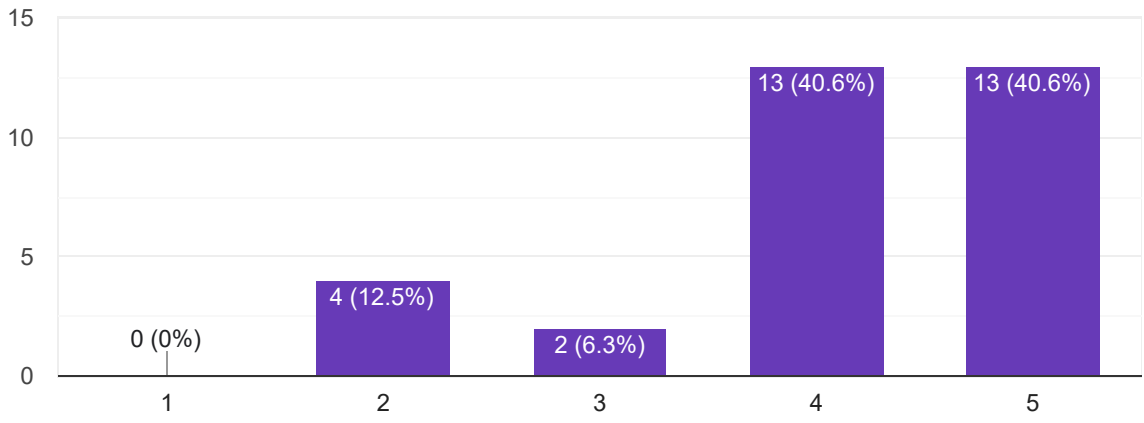


How would you rate the quality of job satisfaction offered by SD college Barnala 32 responses



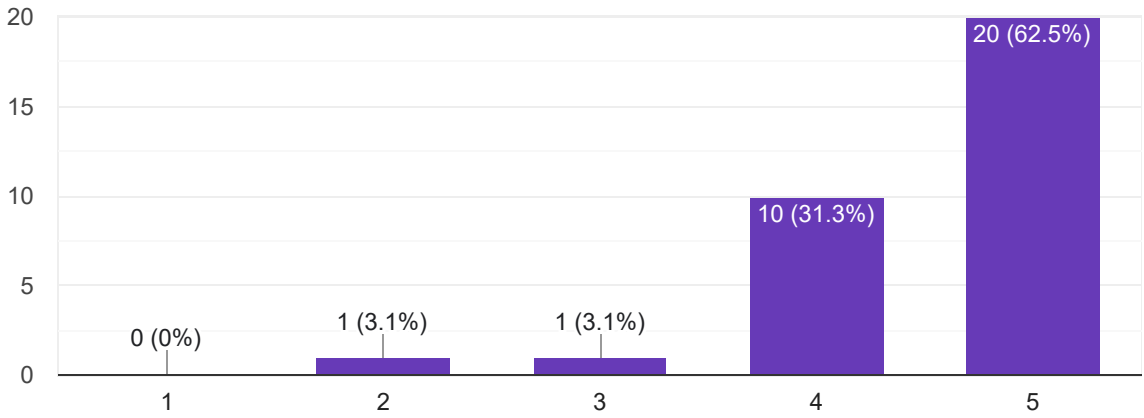
How would you rate opportunities for personal and professional growth at SD College, Barnala? 32 responses

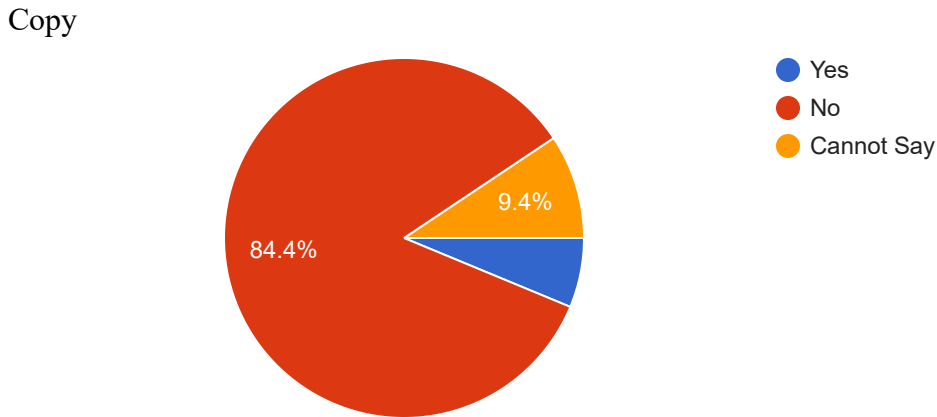


How would you rate the hygiene and cleanliness of the classrooms and basic amenities in the college.32 responses

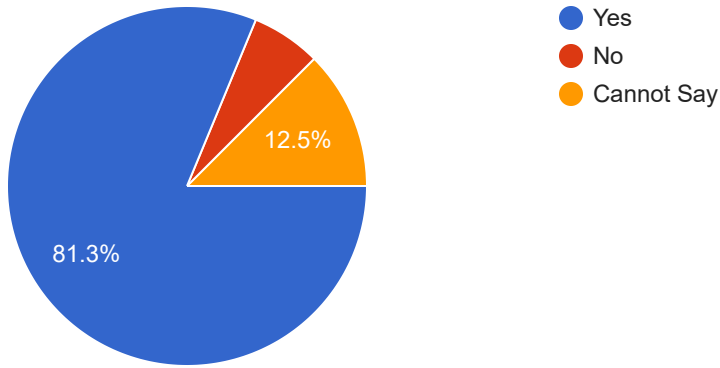

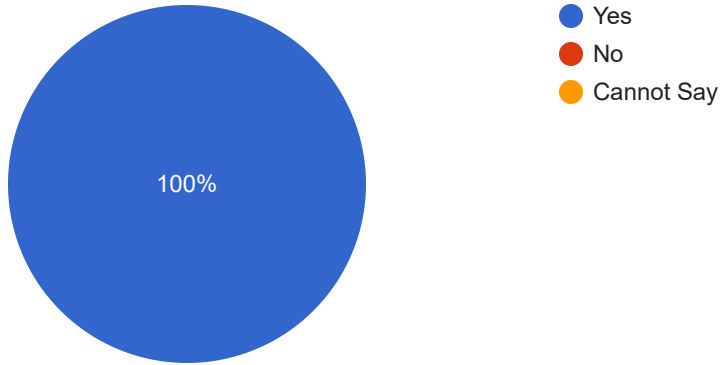


Do you think the syllabus respond to the emerging research and practical application needs of the field? 32 responses

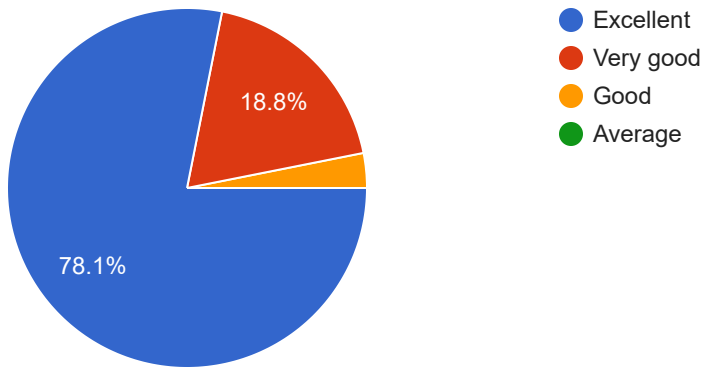
